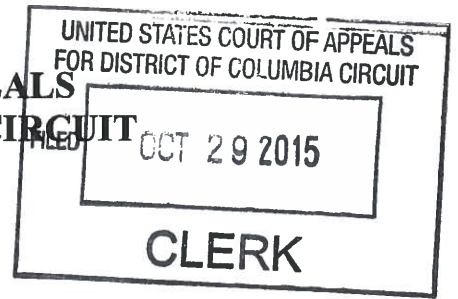

Pursuant to Clean Air Act Section 307(b)(1), 42 U.S.C. § 7607(b)(1), the Administrative Procedure Act, 5 U.S.C. § 702, and Federal Rule of Appellate Procedure 15(a), Basin Electric Power Cooperative hereby petitions this Court for review of the final rule of the United States Environmental Protection Agency (“EPA”) titled “Carbon Pollution Emission Guidelines for Existing Stationary Sources: Electric Utility Generating Units,” published in the Federal Register at 80 Fed. Reg. 64,662 (Oct. 23, 2015) and to be codified at 40 C.F.R. Part 60, Subpart UUUU. A copy of EPA’s final rule is attached to this Petition.

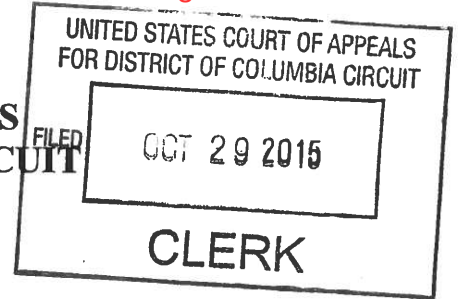


RULE 26.1. CORPORATE DISCLOSURE STATEMENT
