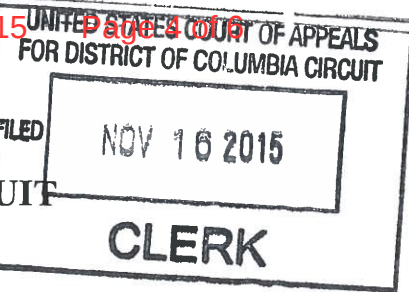

OF PETITIONER LG&E AND KU ENERGY LLC**


Pursuant to Fed. R. App. P. 26.1 and D.C. Circuit Rule 26.1, petitioner LG&E and KU Energy LLC files the following statement:

LG&E and KU Energy LLC is the holding company for Louisville Gas and Electric Company (“LG&E”) and Kentucky Utilities Company (“KU”), regulated utilities that serve a total of 1.2 million customers. LG&E serves 321,000 natural gas and 400,000 electric customers in Louisville, Kentucky and 16 surrounding counties, whereas KU serves 543,000 customers in 77 Kentucky counties and five counties in Virginia.

LG&E and KU Energy LLC is a wholly-owned subsidiary of PPL Corporation. Other than PPL Corporation, no publicly-held company owns 10% or

more of any of LG&E and KU Energy LLC's membership interests. No publicly held company has a 10% or greater ownership interest in PPL Corporation.
